### Release waiver of Liability, and Indemnity Agreement

\_\_\_\_\_ - (insert / print name of parent or guardian), on my own behalf and on behalf of all children for whom I am the parent or legal guardian (collectively, "Children"), hereby release, waive, and discharge The Good Shepherd's Little Lambs Preschool, its director, officers, employees, and agents (collectively, "LLP") from all liability they may have to me, to the Children, and to the personal representatives, heirs and the next of kin of the me and the Children, for any loss or damage, and any claim or demands on account of injury to persons or property, even those resulting in death of myself or the Children, whether caused by the negligence of LLP or otherwise, while I or the Children are in, upon, or about the premises or any facilities or equipment therein or while participating in any service or program affiliated with LLP.

On behalf of myself and the Children, I understand that the risk of injury and damage exists in many forms with the following being only some of them: being in contact and interacting with others; the sudden and unforeseen malfunctioning of equipment; use of play areas or play equipment; a person's reaction to exercise, instructions, foods and friends, dietary recommendations and the like; slipping and falling; the effects of natural disasters; acts of terrorism; and the effects of exposure to any and all presently known and unknown viruses (including but not limited to SARS-CoV-2, the novel coronavirus that causes COVID-19), pathogens, bacteria, germs, and diseases. These risks, and all other risks not listed here, are included in this waiver, release, and discharge of liability.

On behalf of myself and the Children, I hereby indemnify and agree to defend and hold LLP harmless and covenant not to sue LLP and each of them from any loss, liability, damage or cost they may incur due to the presence of the myself or the Children in, upon or about the LLP premises or in any way observing or using any facilities or equipment or LLP or participating in any service or program affiliated with LLP whether caused by the negligence of LLP or otherwise.

On behalf of myself and the Children, I hereby assume full responsibility for and risk of bodily injury death, and property damage to me and / or to the Children due to negligence of LLP or otherwise while in, about or upon the premises of LLP or any facilities or equipment thereon, or while participating in any service or program affiliated with LLP.

I further agree that this Release, Waiver of Liability, and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Washington and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
